Property Tax and Water Credit Program for Low-Income Persons

INFORMATION SHEET

Low-Income persons who qualify may apply for a tax credit of up to \$200.00 and a water credit up to \$200.00.

DO YOU QUALIFY?

Please review the following **ELIGIBILITY CRITERIA**.

- Total household income must be \$48,358 or less.

Household income is defined as the **combined** gross income shown on line 15000 of the Canada Revenue Agency Notice of Assessment or Notice of Reassessment for all property owners, their spouses and occupants 18 years of age and older who are not attending school on a full-time basis. **A copy of the previous year's Notice of Assessment or Notice of Reassessment must be submitted for each owner, each spouse of an owner and occupants 18 years of age and older who is not attending school on a full time basis.**

Exception: if proof is provided that the applicant's spouse is involuntarily separated for reasons beyond their control (hospital or nursing home) and that person's income is being applied toward alternate living accommodations, then the spouse's income is excluded from total household income

- **Exception:** if proof is provided that the co-owners do not reside on the property, then their income is excluded from total household income
- The value of the property as shown on the latest assessment roll must be less than or equal to \$158,000.
- The applicant must own and occupy the property as their principal residence and the property must be in the residential property class.

Applications including all supporting documentation must be received by the due date in order to qualify.

HOW THE PROGRAM WORKS

- Persons receiving assistance through the City's Property Tax and Water Credit Programs for Low Income Seniors and Low Income Persons with Disabilities are not eligible for assistance under this program.
- The applicant must apply each year to be considered for this program.
- The applicant must have owned and occupied a property in the City valued at \$158,000 or lower for the entire previous year.
- Only one application is permitted per household.
- If you qualify for a tax credit, a credit amount up to \$200.00 will be applied to your tax account.
- If you qualify for a water credit, a credit amount up to \$200.00 will be applied to your water account.
